DISTANCE FIRED: 50 feet

RIFLE: Smallbore Free Rifle – Rule 3.1

SIGHTS: Any – Rule 3.7

TARGETS: NRA Official 50 ft., USAS/NRA 50 target (3-Position) and A-17 (4-Position). **Notice:** All fired targets must be retained until the challenge period for the National Indoor Championship has ended, which is two weeks after the final results bulletin is mailed to all competitors. The top 3 individuals and the top team's targets will be submitted to the NRA for score verification.

RULES: 2009 NRA Smallbore Rifle Rules will govern.

SCORE CARDS: Special score cards will be used **and MUST BE SIGNED BY THE COMPETITOR TO BE CONSIDERED FOR THE NATIONAL BULLETIN.** If no classification is circled, a competitor or team will be placed in the **Master Class.**

CATEGORIES: Categories will not be recognized in the 3P and 4P Sectionals.

CLASSIFICATION: Each competitor will be placed in one class according to the NRA Classification System and shall be prepared to exhibit his classification card or Temporary Score Record Book. Unclassified competitors will fire in the Master Class if they do not have an assigned classification (Rule 19.6). Teams will be classified according to rule 19.12.

SOUVENIR PINS: Sponsor will furnish a pin to each competitor.

CHALLENGES: A challenge fee of \$1.00 will be charged for each challenge made (See Rule 16.1 for correct procedure).

INDIVIDUAL ENTRIES: Open to Adults and Juniors (NRA membership is not required). Individuals must complete a special sectional entry card. Entry cards must specify classification and all applicable categories for national awards. Cards must be signed by the competitor and appropriate fees paid to the match sponsor.

TEAM ENTRIES: Open to teams whose firing members represent a club affiliated with NRA (Rule 2.11 or 2.11.1), a Regular Service unit, National Guard, or Reserves (Rule 2.13). A team composed of shooters who are not all in the same category is a mixed team. Mixed teams in Sectionals may fire for **open awards only**. Scores for mixed teams will be reported to NRA for classification and will be used for **open awards only** on the National level.

A team will consist of four (4) firing members representing a club as defined by Rules 2.11, 2.13, or 2.14. Pick up teams, teams composed of shooters who cannot prove membership in the same club or group (Rule 2.10) will not be allowed to participate. Since team matches are unfired (paper match team), all teams **MUST** be named and entered **BEFORE** any member of the team begins individual firing. Alternates must also be named before firing and used to substitute only for someone who has not yet fired. Team participation should be indicated on individual entry card. Team entries must be made in person at the Statistical Office. 4-Position team match will be fired on the same relay as individual matches during the second stage (for 3-Position competitors) of each relay.

ENTRIES LIMITED: Entries are limited to 12 competitors for each relay and a maximum total of 36 competitors (3 – 12 person relays) which is the capacity of the range for the time allotted. Persons making entries within the time limit which cannot be accepted will be notified and their fees will be returned.

ENTRIES CLOSE: Individual match entries must be received no later than Monday, March 8, 2010. Team entries must be made prior to the start of firing of any member of the team.

POST ENTRIES: Post entries will be accepted to the capacity of the range, provided such entries will not require extra relays.

SIGHTING SHOTS: Unlimited sighting shots will be allowed in all matches and must be taken within the time limit (Rule 8.2) and may only be fired before the firing the first record shot for each stage of the match (Rule 9.2).

SQUADDING: Will be assigned by the Statistical Office.

ELIGIBILITY: A competitor (individual or team) may enter more than one Sectional tournament of each kind in 2007. However, the individual **MUST declare before firing** if the Sectional being fired is for **score only or for the National Championship**. Competitors may enter other types of Sectionals if eligibility limitations permit. Competitors entering for “score only” are NOT eligible for awards in the local sectional or the National Championship.

A foreign competitor is eligible to participate on the Sectional and National level (Rule 2.1.1); however, only U.S. citizens may win the First, Second and Third Place National Individual and Team Championship awards.

NRA SMALLBORE RIFLE DISTINGUISHED AWARD: A leg toward the NRA Smallbore Position Distinguished Award can be earned by winning a place in the top scoring 10% on the national level, in 4-Position or NRA 3-Position Smallbore Rifle.

FIRING REGULATIONS FOR MATCHES: Since Sectional scores are to be used to determine National Champions, all Sectionals **MUST** be conducted in the prescribed manner.

1. Individual matches: If range facilities permit, two targets for the match should be mounted simultaneously, and an additional three minutes will be allowed for target change of the second stage or match as needed. When only a single target is mounted, due to range limitations, three (3) minutes for each target change will be added to the total firing time for the match.
2. Sighting Shots: Unlimited number may be fired any time during the 4-Position and NRA 3-Position sectional and may only be fired before the beginning of each match or position or anytime after changing targets for International 3-Position or Air Rifle (Rule 9.2).
3. Shooting time: time allowed includes sighting shots. Time remaining from one position may not be carried over to a following position regardless of the method of changing targets.
4. Firing Order: All matches (1,2,3,4) must be completed by all competitors on a relay before the next match is started. Matches must be fired in the order identified in each of the program sections.

SECTIONAL INDIVIDUAL CHAMPIONSHIP AWARDS:

Provided by the National Rifle Association:

3-Position Open Sectional – Match 4 and 4-Position Open Sectional – Match 5

Winner – Gold NRA Sectional Medallion and 15 award points (minimum of 2 competitors)
2nd Place – Silver NRA Sectional Medallion and 10 award points (minimum of 15 competitors)
3rd Place – Bronze NRA Sectional Medallion and 5 award points (minimum of 25 competitors)

An individual or team winning a place award will not be entitled to a class award in the same match. Such class awards will be passed down to the next eligible individual or team.

Awards will be given in Master, Expert, Sharpshooter, and Marksman classes.

First Place – 7 NRA award points with at least 5 competitors in class
Second Place – 5 NRA award points with at least 8 competitors in class
Third Place – 3 NRA award points with at least 11 competitors in class

3-Position National Smallbore Championship – Match 6

: Winner – Nat'l Championship Gold Medallion, Butterman Trophy Plaque and 50 award points
2nd Place – Silver Medallion and 40 award points
3rd Place – Bronze Medallion and 30 award points
High woman: - Norwegian Trophy Plaque

Awards will be given in Master, Expert, Sharpshooter, and Marksman classes.

First Place – 10 NRA award points with at least 5 competitors in class
Second Place – 8 NRA award points with at least 10 competitors in class
Third Place – 6 NRA award points with at least 15 competitors in class

3 NRA award points in each class will be given for each 5 entries or major fraction thereof in a class over 15.

4-Position National Smallbore Championship – Match 7

Winner - National Championship Medallion, Lister Plaque, Championship Banner, and 50 NRA award points.

Second Place - Silver National Championship Medallion and 40 NRA award points

Third Place - Bronze National Championship Medallion and 30 NRA award points

Woman Champion: Sea Girt Trophy Plaque

Senior Champion: NRA Trophy Plaque

A High Visitor award will be given to any non-US citizen who places first, second, or third overall.

Awards will be given in Master, Expert, Sharpshooter, and Marksman classes.

First Place – 10 NRA award points with at least 5 competitors in class

Second Place – 8 NRA award points with a least 10 competitors in class

Third Place – 6 NRA award points with at least 15 competitors in class

3 NRA award points in each class will be given for each 5 entries or major fraction thereof in a class over 15.

SECTIONAL TEAM CHAMPIONSHIP AWARDS:

Provided by the National Rifle Association:

3-Position Open Sectional Team – Match 5 and 4-Position Open Sectional Team – Match 6

Winning Team – 5 NRA award points to each member. The NRA will provide this award provided there are 2 or more teams.

3-Position National Team Championship – Match 7

: Winning Team – 5 Chief Army Reserve Trophy Plaques
Second Team – 40 award points
Third Team – 32 award points

Awards will be given in Master, Expert, Sharpshooter, and Marksman classes.

First Place – 5 NRA award points to each team member

Second Place – 4 NRA award points to each team member

3 NRA award points to each team member will be given in each class for every 5 teams over 20.

4-Position National Team Championship – Match 8

Winning Team – 5 National Club Trophy Plaques

Second Team – 40 award points

Third Team – 32 award points

Awards will be given in Master, Expert, Sharpshooter, and Marksman classes.

First Place – 5 NRA award points to each team member

Second Place – 4 NRA award points to each team member

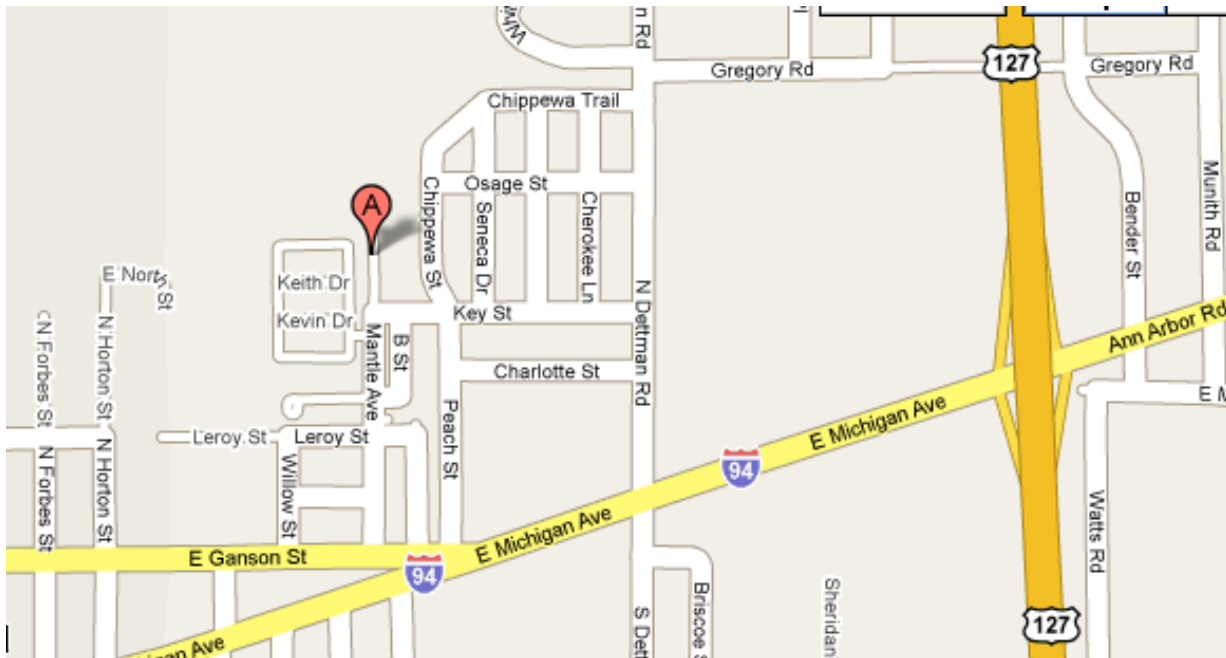
3 NRA award points to each team member will be given in each class for every 5 teams over 20.

Directions: Exit I-94 at US-127 S. Proceed south to the first exit (Michigan Avenue) exit at Michigan Avenue and turn right (west) on Michigan Avenue.
